Objective and Investment Policy

The Fund aims to achieve annualised total returns before fees of 8 - 12% over an economic cycle (5-7 years typically). Capital is in fact at risk and there is no guarantee that a positive return will be achieved over this or any period.

The Fund aims to meet its investment objective primarily by investing in a portfolio of stocks quoted across the globe which have at least 35% of their revenues or profits coming from emerging markets, with the majority of the emerging market exposure coming from Asia. The Sub-fund may also invest in other collective investment schemes, transferable securities, money market instruments, deposits, cash and near cash. There will be no particular emphasis on any industry or economic sector.

Derivatives (that is sophisticated investment instruments linked to the rise and fall of the price of other assets) may be used to manage the Fund more efficiently. The Fund may also hedge part or all of the equity market risk arising from its underlying investments in order to attempt to reduce the risk of potential capital losses.

The Fund has the discretion to invest in a range of investments as described above.

You can buy and sell shares in the fund on any business day.

The fund aims to distribute available income every six months.

Risk and Reward Profile

The Risk and Reward Indicator table demonstrates where the Fund ranks in terms of its potential risk and reward. The higher the rank the greater the potential reward but the greater the risk of losing money. It is based on past data, may change over time and may not be a reliable indication of the future risk profile of the Fund. Historical data may not be a reliable indicator of the Fund's future risk profile. The risk category shown is not guaranteed and may change over time. The lowest category does not mean "risk free".

The Fund is ranked 5 because weekly historical performance data indicates that it has experienced relatively high rises and falls in market prices historically.

The following risks are material in addition to the risks captured by the indicator above:

- Counterparty risk: The Fund can conclude various transactions with contractual partners. If a contractual partner becomes insolvent, it can no longer or can only partly settle unpaid debts owed to the Fund.
- Market Risk: External factors can cause an entire asset class to decline in value which would result in a decrease in the value of investments.
- Currency Risk: As the Fund invests in collective investment schemes which have exposure to overseas securities, movements in exchange rates may, when not hedged, cause the value of your investment to increase or decrease.
- Risk from use of derivatives: Investment in derivatives may result in gains or losses that are greater than the original amount invested.

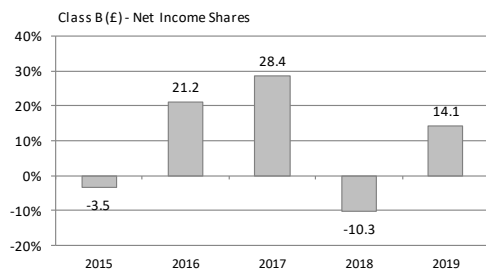
